- **3.** The applications dully completed with supported attested documents should reach personally or through registered couriers service to undersigned on or before due date of closing.
- **4.** Only shortlisted candidates will be called for interview. Short listing will be done either by written test or by their pre-interview marks or both.
- **5.** Their services will be governed, under the Khyber Pakhtunkhwa Medical & Teaching Institutions Reform Act 2015.
- 6. If the closing date fixed for the receipt of application form falls on an official holiday, the next working day shall be considered as the closing date.
- 7. An application after the closing time and date shall stand rejected.
- **8.** The Scrutiny Committee shall be competent to reject applications which are incomplete. However the aggrieved candidates can appeal to the competent form of HMC for review. The decision of the competent form there of shall be final.
