5. Tender /bids will be opened in the presence of the bidders or their authorized representatives, who choose to attend at the address below, at 11:00 am on the same date and time i.e 02-07-2020 by the HMC Tender Opening / Selection Committee.
6. Proprietary Certificate if applicable must be attached.
7. Any bids received later shall be rejected as per KPPRA rules.
8. The firm must be on FBR Active Tax payer list.
9. The taxes will be deducted as per rules.
10. All the firms must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRRA) where applicable.
11. The firms must provide detail of NTN #, Sales Tax #, Income Tax # and professional Tax # or other Taxes to HMC.
12. The bidder will be bound to ensure the fulfillment of the said order within stipulated period as per supply order, otherwise penalty will imposed as per Govt: rules. The competent authority reserves the right to extend the work order period on mutual understanding if needed.
13. No conditional tender will be acceptable.
14. During Selection of the above heads the firms should bring the sample.
