7. **For Serial No 01:** Those firm who have to pay MTI-HMC dues, shall not be consider as eligible & shall be considered as non-responsive.
8. **For Serial No 01:** Documentary proof on Judicial Stamp Paper that the prospective bidder does not have any pending dues to pay to MTI-HMC.
9. The firm must be on FBR Active Tax payer list.
10. The taxes will be deducted as per rules.
11. **For Serial No 01 :** All the firms shall be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA).
12. The firms must provide detail of NTN #, Sales Tax #, Income Tax # and professional Tax # or other Taxes to MTI-HMC.
13. **For Serial No 01:** Any firms / contractors that had gone to the court of law against MTI-HMC shall not be allowed for bidding, they shall not apply.
14. **No conditional tender/bid will be acceptable.**
15. The contractor / workers after receiving contract will not be allowed for any strike / protest /complaint, otherwise contract will be canceled.
