8. Tender /bid will be opened by the tender / selection committee of MTI/HMC, in front of Firm / bidders in the conference room or conference Hall of Procurement Deptt of MTI/HMC.
9. Original company prescribing letter pad sealed & signed (Every Page) should be submitted in words & figures.
10. The firm must be on FBR Active Tax payer list.
11. The taxes will be deducted as per rules.
12. The firms must provide detail of NTN #, Sales Tax #, Income Tax # and professional Tax # & all other Taxes to HMC.
13. **No conditional tender will be acceptable.**
14. **During Selection of the above heads the firms shall bring the sample (Mandatory).**
15. **Documentary proof on Judicial Stamp Paper that the prospective bidder does not have any pending dues to pay to MTI/HMC.**
