Subject: <u>Minutes of Pre-bid meeting of Ophthalmic (Equipment and Consumables)</u>
PICO for the FY 2021-22.

The subject meeting was held on **10/12/2021** at **10:00** am, under the chairmanship of Deputy Director Academics, PICO in CEC Cell, PICO. List of participants is attached.

**2.** The meeting started with recitation from the Holy Quran. Following are the decisions of the meeting:-

## i) Ophthalmic surgical Consumables

Two companies' representatives participated for the consumables. The PICO Purchase Secretary explained the detailed purchase procedure and stated that following few changes have been made in the list of items as a result of Pre-bid meeting recommendations:-

Moreover, it was also explained that the bidding procedure will be single stage-one envelope involving only financial proposal, however, after selection of the bid, final selection will be made on the basis of approval of the sample by the PICO Technical Committee. On a query regarding CDR value, the PICO Purchase Secretary explained that CDR value will be calculated as follows:

(Total of the per unit rate of the consumables x 500= Resultant x 2%= CDR

## ii) Ophthalmic Equipment

For Ophthalmic equipment representatives of five companies participated. The PICO Purchase Secretary explained that the said equipment will be procured as per KPPRA Rule 6 2 (b), Single Stage-Two envelope Procedure involving both Technical and Financial proposals in one envelope. The representative of Links Communication System Pvt. Limited asked as whether a company can offer product/equipment with higher specifications than the required. The

Chairman PICO Purchase Committee affirmed that yes it can be done; however, there are no additional marks for higher or better product specifications. He further explained that 10 marks reserved for experience certificates will be awarded on production of satisfactory certificates from the previous vendors from Pakistan. The representative of Medical Equipment Systems suggested some changes in the specifications for improvement, which were thoroughly discussed and following changes were made in the specifications:
